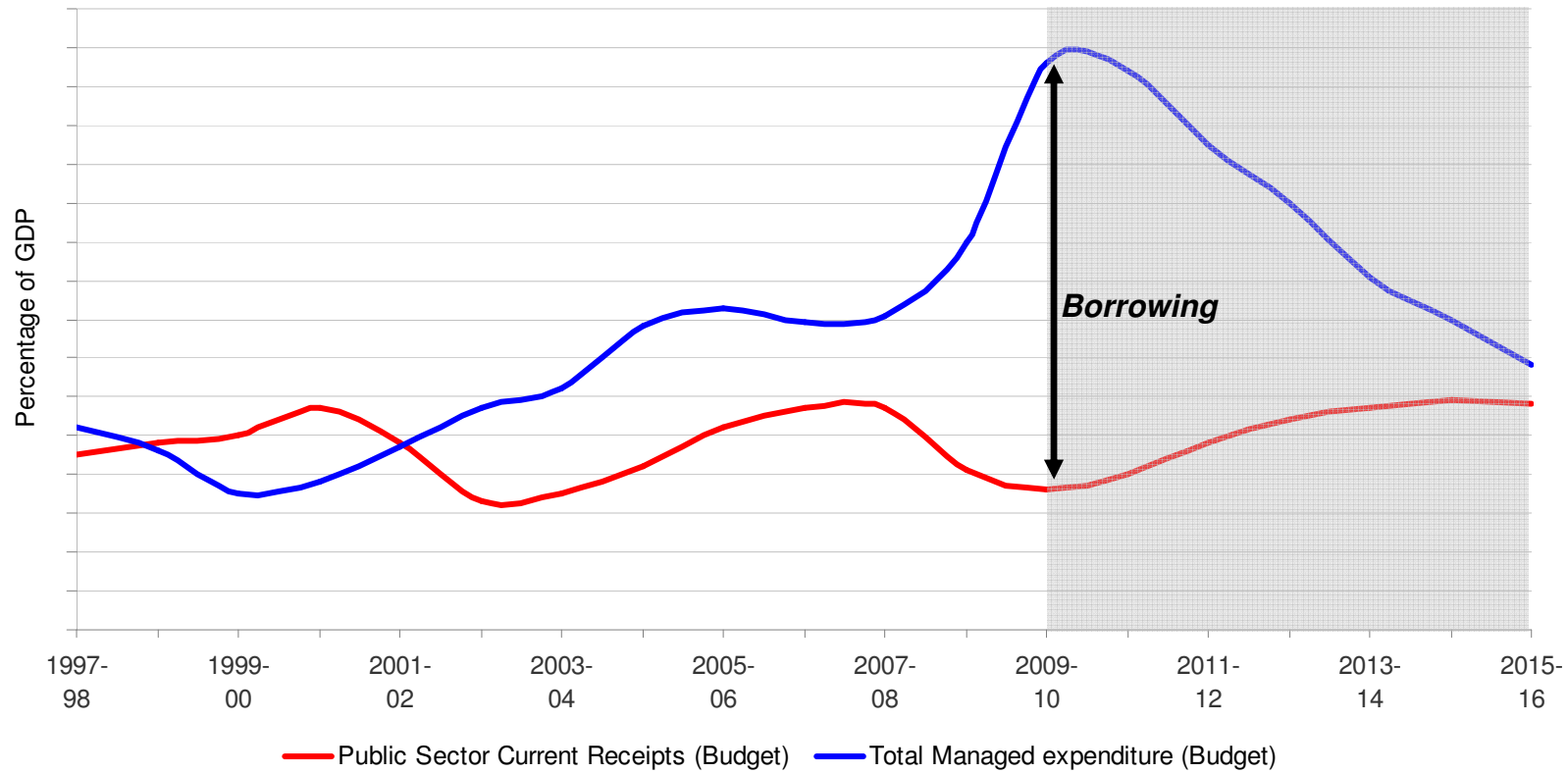

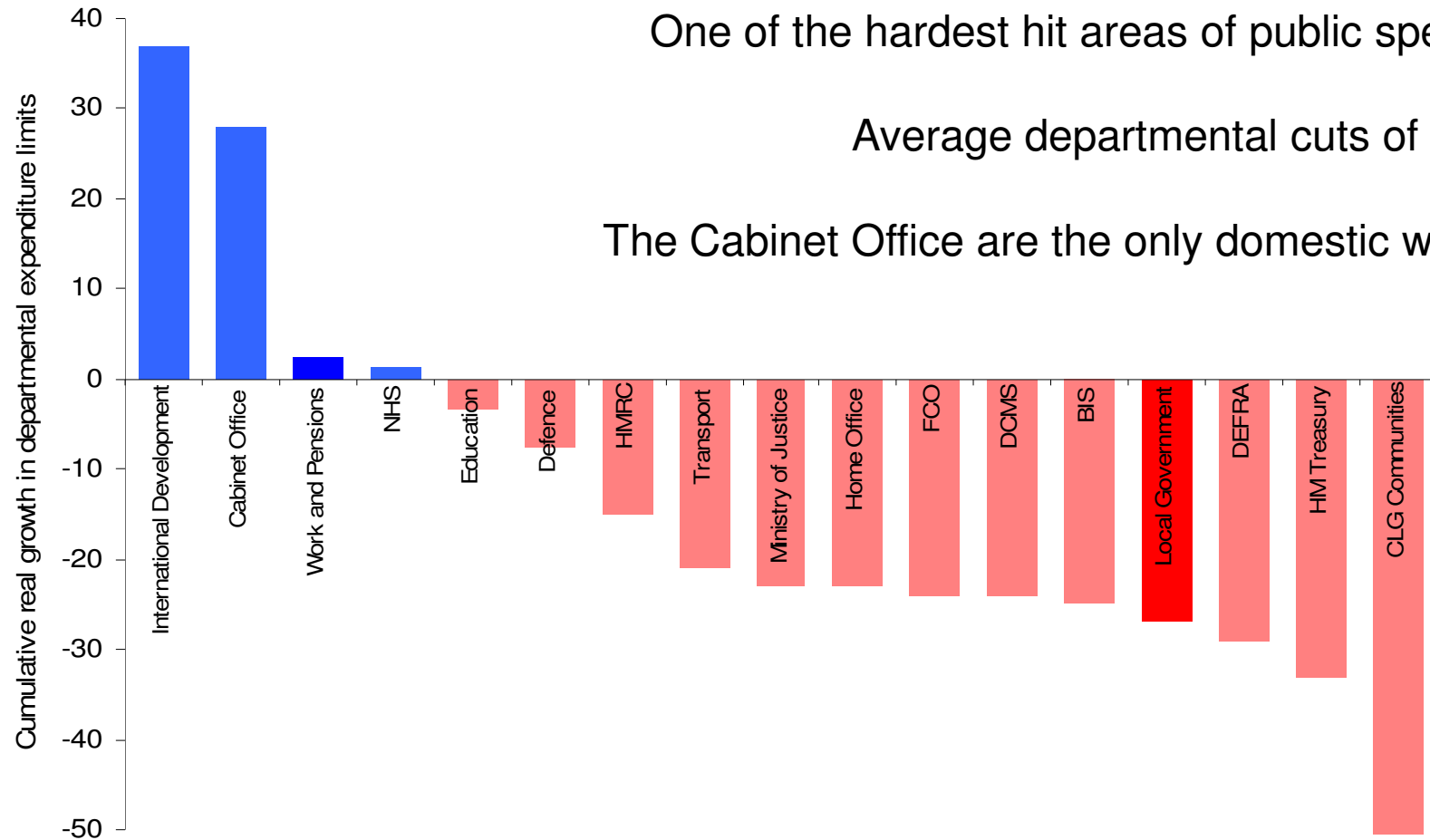

## National initiatives

**Cabinet Office gained £470 million to support community groups**



**These initiatives compliment wider reforms in school provision, personal care services and the national planning framework**

## The impact at local level

**Transforming services and assets** – changing the way local public services are delivered, with an emphasis on increasing the role of individuals, families, community groups and the voluntary sector;

**Building social capital and capacity in civil society** – developing the capacity and readiness of individuals, families, neighbourhoods, interest groups, community groups and the voluntary sector to tackle social issues and deliver public services; and

**Empowering communities** – giving individuals and communities greater influence over local decision-making and opening service providers to greater public scrutiny.

*“Society is best served when power is decentralized and distributed throughout the state and society”*

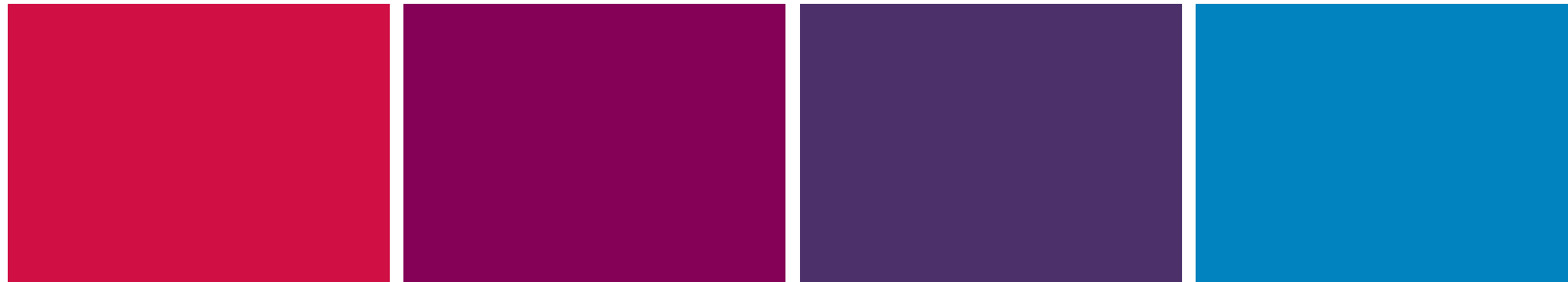
